USE: This form is used if the name change is a result of marriage, divorce or pending divorce and you only want a corrected registration card but not a corrected certificate of title. **No fees are required with this option.**

INSTRUCTIONS:

A. Change or Correction of Name

- (1) Check marriage, divorce or pending divorce block.
 - (a) If name change has been made due to marriage or divorce, no proof is required.
 - (b) If name change has been made due to pending divorce, please attach a copy of the written notice to resume a prior surname.
 - (i) This notice must include the caption and docket number of the proceeding in the divorce and be date stamped from the court.
- (2) Complete Section A with the Vehicle Information
- (3) Complete Section B, using the correct name.
- (4) Complete Section C, using the former name.
- (5) Complete Section D, for certification.

“APPLICATION FOR CORRECTION OR CHANGE OF NAME”**

USE: This form is used in the following instances:

- a. if your name change is a result of marriage or divorce and a corrected certificate of title is requested.
- b. If your name change is by permission of court.
- c. If you desire to use a name other than (1) birth name, (2) spouse's surname, or (3) a name given through court.

INSTRUCTIONS:

- A. Change or Correction of Name. **NOTE:** The Pennsylvania Certificate of Title must be attached along with the \$22.50 fee.
1. Check reason for name change
 - (1) If name change has been made due to marriage or divorce, no proof is required.

- (2) If name change has been made due to pending divorce, attach a copy of the written notice to resume a prior surname.
 - (3) If a name change by permission of the court, attach a certified copy of the court order.
 - (4) If you wish to use a name other than your birth name, spouse's surname, or a name given by a court order, you must provide the following:
 - (a) A copy of a social security card or record.
 - (b) Copies of documents from 2 other sources, such as: Tax records, selective service card, passport, any photo ID issued by a governmental agency, or baptismal certificate or banking records in the desired name.
2. Complete Section A with the vehicle information
 3. Complete Section B, using the correct name
 4. Complete Section C using the former name
 5. Complete Section D, only if the Pennsylvania Certificate of Title is not attached. NOTE: An additional \$22.50 fee is required.
 6. Complete Section E for certification
 7. Complete Section F, only if there is a valid lien recorded on the certificate of title record. This section must be completed by the lienholder.
